





### **IV.** Preparation

- 1. After opening the box, read this introduction carefully, check all the packed parts are complete by cross checking of all the components. Examine for shipping damage. If the unit has been damaged or has a finishing defect, please contact your local distributor within 2 business days. Please note that Bath Authority <sup>TM</sup> / DreamLine <sup>TM</sup> will not replace any damaged product or parts free of charge, ONCE the product has been installed. You distributor's responsibility for damage in transit is limited after the shower package has been transferred to the transportation company, so you may have to contact the transportation company directly to report damage. Contact your distributor or DreamLine if you have any questions.
- 2. You shower consult your local building codes on questions on installation compliance standards.
- **3.** Install all of the required plumbing. Use a competent and licensed (if required by local code) plumber for all plumbing installation.
- **4.** Please, note that there are some adjustments and drilling might be necessary during the installation process.

### V. Column Installation

Refer to the technical diagram to choose the proper location for your shower column. You can adjust the column's vertical position based on the person's height. Measurements given in the technical diagram are based on the average human height-68 5/7").

- 1. Secure shower arm (1) on to the column, do not forget to use O-ring (10) on the shower arm.
- **2.** Place gasket (9) into L-fitting (8).
- **3.** Connect L-fitting (8) with Shower arm water supply fitting (11).
- 4. Place rubber washer (6) into Shower head (7).
- 5. Connect the Shower head (7) to the Shower arm (6).
- Choose the proper location for your column and mark the drill holes (1). Drill the holes on the distance 1 3/4" from each other.
- 7. Insert Wall anchors (2) inside the holes.
- Tighten the screws (3) to the wall with stainless steel washers (12). Leave the screw heads 1/4" from the wall.
- **9.** Connect the flexible hot (13) and cold (14) water supply lines to hot (15) and cold (16) water outlets (supplied by your plumber) accordingly.
- 10. Hang the Mounting bracket (4) on the screws (3) secured in the wall.
- **11.** Connect the handheld shower head (19) to the hose (17) placing the rubber washer (18) in the fastening nut and tide it by hands.

DreamLine<sup>™</sup> does not recommend the use of harsh abrasive cleansers on any of its products. Harsh cleansers will damage the metal or glass finish on your shower enclosure or jetted shower.

### **REQUESTING SERVICE**

Here's what you need to do if you require service:

Contact the dealer who sold and/or installed the product. They should be able to solve any problems you may have.
If your dealer or contractor cannot solve the problem, they will contact or supply you with the name of the local DreamLine<sup>™</sup> Distributor or a DreamLine<sup>™</sup> Direct Technical Specialist

4. Include all pertinent information regarding your claim, including a complete description of the product, model numbers, colors, finishes, and the date the product was installed. Include a description of the problem and a photocopy of your invoice and purchase receipt(s) for the products involved. Also please provide information on the name and contact telephone numbers of the contractor and distributor.

Please note that under any circumstances, DreamLine<sup>™</sup> products <u>should not</u> be returned to your dealer, distributor or directly to DreamLine<sup>™</sup> without a written Return Merchandise Authorization (RMA).

#### LIMITED ONE-YEAR WARRANTY

This warrantee extends only to the original owner/end-user for personal household use only. For commercial uses, additional limitations may apply.

DreamLine<sup>™</sup> warrants acrylic surface against blistering or cracking and chipping resulting from defect in the acrylic surface material when used under normal condition and service for a period of one (1) year from the purchase date.

DreamLine<sup>™</sup> warrants mirrors, shower doors, shower massage systems, faucet finishes and fittings to be free from defects in workmanship and materials under normal use and service for a period of one (1) year.

DreamLine<sup>™</sup> further warrants the structure of the acrylic shell against loss of water through the fiberglass laminate of the acrylic body as a result of defect in materials and workmanship for a period of five (5) years from the purchase date.

DreamLine<sup>™</sup> will, at its election, repair, replace, or make appropriate credit adjustment where DreamLine<sup>™</sup> optional inspection discloses any such defects occurring in normal usage within the warrantee periods. **Please note that DreamLine<sup>™</sup> is not responsible for any installation or removal costs.** 

Improper modification of any enclosure, jetted shower or shower column components may void the warrantee - so please install the product as directed in the manual. This warrantee does not cover any claim arising from abuse, misuse, negligence, accident, improper installation or operations on the part of the purchaser. This warrantee is void if the DreamLine<sup>™</sup> product is subject to alterations, or if repairs are attempted by anyone other than an authorized agent of DreamLine<sup>™</sup>. This warrantee does not extend to any plumbing or components installed by dealers, installers or by any party other then DreamLine<sup>™</sup>.

# Implied warranties, including that of merchantability or fitness for a particular purpose, are expressly limited in duration to the duration of this warranty. DreamLine™ disclaims any liability for special, incidental, or consequential damages.
